Mary Jean Povlock (formerly Barbone), of Edgewater, Florida, age 93, passed away July 12, 2024. She was born Dec. 25, 1930, in Salamanca, New York, to Eva (Kalamanka) and Phillip Povlock. She graduated from Salamanca High School and went on to attend Syracuse University, earning a Bachelor of Science in 1952. She was a member of Kappa Delta Sorority Sigma Nu Chapter.

After graduation, she was employed by Cornell Cooperative Extension in Delaware and Sullivan counties, New York. When she married and had children, she stayed home to raise them, teaching them to cook, sew and
