Together, Bill and Judy showered their boys with love, never missing a chance to

Judy taught kindergarten at Lewiston-Porter for 37 years, where she ignited imaginations and created memories for so many children. Following her retirement in 2007, she began “Storytime with Miss Judy” at the Lewiston Public Library. piest times. For the love and care she shared with so many, her family was always her priority. How she managed to be at every game or event, always available for a call to chat or catch up, running to appointments, and always being there for friends, relatives or anyone in need in the community, we’ll never know. Right until the end, she made sure everyone else was taken care of first.

Judy was predeceased by her parents; her beloved in-laws, Cesarino and Lucia; brother-in-law Barry; and sister-in-law Franca. In addition to her husband and children, Judy is survived by her sister-in-law, Myriam (Tom) Witkowski; brother-in-law Dennis (Linda) Tosetto; and her nieces and nephews: David (Christine) Tosetto, Jennifer (Robert) Woods, Cynthia Sanchez and Jacqueline (Jon) DiBernardo, all of whom she loved and looked after as her own.
